7. Water Quality Reports

- a. Dr. Chuck Jacoby, SJRWMD, gave the water quality report for the north and central IRL.
- b. Jose Vega, St Lucie County, stated that he was asked to provide a quarterly estimate of lower basin runoff to the IRL Council. Rain and flow data comes from the SFWMD DB hydro Database, TN/TP measurements come from the FDEP wash model for the last three quarters.
 - Quarter 1 44 TN, 9 TP
 - Quarter 2 35 TN, 7 TP
 - Quarter 3 167 TN, 31 TP

Total for the year is 246 TN 46 TP of local basin runoff coming out of the north fork seems to prove the increase of rain as a contributing factor. The County would like to continue to provide this update quarterly.

- 174 active projects in the IRL watershed in addition to in-house projects that are ongoing;
- Thanked Bob Musser, Mark Granger, Mike Middlebrook, and Commissioner Dzadovasky for assisting with the EPA project tours;
- 24 new projects for a total of 51 active projects;
- Multi-year communication plan is being worked on;
- Annual report is expected in early January;
- A Climate Ready Estuaries document will be developed for the public and local governments by the end of the fiscal year. The OneLagoon.org website will be finished over the next several months and the current website will be retired.
- Staff is in the process of developing a quarterly newsletter For the Management Conference and the public.
- IRLNEP Executive Director will provide monthly updates to Management Conference, in the first week of every month.
- Vital Signs video will expand into more videos on the website covering each of the vital signs as an introduction to each section of the CCMP.
- Duane De Freese requested a Board Motion to direct staff to utilize \$1600 donated by Ron Jons Surf Shop for Prize money for winning photos submitted to the IRL Photo Contest.

The site updates users regarding all things Florida and the issues we are facing with regard to water issues in Florida. Executive Order 19-12 has been completed or is currently ongoing.

- d. Stacey Hetherinton C-44 ribbon cutting is today, Martin County allocated \$27 million? to the project. C23-C24 advocation partnership needs \$200 million?, Martin County has adopted a 10-year septic to sewer plan that received funding from FDEP.
